### Second Public Comment:

Resident inquired as to whether the pipeline was going to go down the middle of the road. Jeff Wright indicated that is why the surveying was being done, however, the goal was to try to keep the construction in the road right-of-way. The 30% design phase would give much more detail. CEO Wright indicated, "We will try to make as many improvements as we can, and we will also disturb as little as possible". An offer has been made to communities that if any upgrades were requested, we would be glad to work them into the design phase of the project, with their cost participation being for the extra material. To date no one said they would like this done. Jeff Wright further invited citizens to drive the 30 plus miles of construction completed in the last few years, indicating he is proud of what was left to be seen at the end of the project. Trustee Kerbyson indicated he does not understand why Townships have not come forward taking us up on this offer because of the huge cost savings.

Eric Mays wanted to know if there is a regular monthly meeting schedule and if the KWA is still on track with progress.

#### **Board Comment:**

- Jeff Wright indicated that the Karegnondi Water Authority tries to meet once a month, and at some point will meet quarterly. D'Agostini, the Contractor, is starting the tunnel shaft, which goes into the ground approximately 58 feet where a tunnel machine will be set. This machine is being shipped to the United States and is due to arrive on October 6, and is unique in that it is 100% operated from the surface and not underground.
- The first 35 million dollars was borrowed at a interest rate of 5.04%, which rate CEO Wright was very pleased with.
- Within the next few weeks, the 30% design will be forwarded to the EPA and MDEQ for their comments. Construction bids should be issued in March or April next year.
- Ten Board members will be added to this body, at which time they will be sworn in and become official Board members.
- Jeff Wright indicated one reason the project is being moved forward is because Genesee
  County has only one other option for water supply, and that is to enter into a 30-year
  contract with a bankrupt city. Detroit is considering the setting up a utility authority. The
  City of Detroit is in the hands of the Bankruptcy Court. The judge could set whatever water
  rate they need to in order to balance the budget, and the water fund could be used to bring
  Detroit out of bankruptcy.
- Dale Kerbyson indicated he did receive a letter from the DEQ in which the water pipeline
  was referenced a few times. He believes the MDEQ considers this a viable project that is
  moving forward, even though 30% design is not yet complete.

 Greg Alexander stated that at the last meeting the Board vowed to keep communication as up-to-date as possible on the website, <u>www.karegnondi.com</u>, to continue to try to get our point across and keep the public informed as much as possible.
