Communication:

- CEO Jeff Wright introduced Assistant CEO John O'Brien. Assistant CEO O'Brien reported that approximately two months ago the Board charged the Technical Committee to meet with the City of Detroit to determine if there are any mechanisms in which the KWA and the City of Detroit could work together. City of Detroit's Technical Committee and the KWA Technical Committee were charged with coming up with alternative solutions to the water supply issue. Both sides recognize that the KWA Board and the City of Detroit have the final approval. The Committee has developed four alternatives for consideration. Mr. John O'Brien introduced Lori Koester, Lead Counsel for DWSD.
