Public Comment:

- Ron Cischke, Goodland Township Supervisor Indicated he is still receiving complaints on the roads such as blacktop and ditching. Mr. Cischke handed out a list of the roads that are affected and a copy of a map. Mr. Cischke received a copy of a memorandum, which he indicated he will take back to his Board for their review.
- Ray Hayes, Deerfield Township Supervisor Is very concerned about the amount of gravel that is on Norway Lake Road and Skelton Road, which is a mile south of Columbiaville Road that was used repeatedly. The road has been mushroomed out and needs gravel. He would like this to be addressed by the Board as to a plan and what's going to be done.
- Mark Monson Has two culverts on his property. One is crushed and the other one has been graded so that it is exposed. That will be making his farm inaccessible to machinery that is coming off of Stanley Road. He would ask that that be addressed. He also indicated that near the west side culvert, the road was lowered by he believes at least two feet leaving the culvert exposed at road level with no gravel covering it. It presents a dangerous situation because you are unable to see oncoming traffic when pulling into the driveway. He requests that the road be raised up to where it was and culverts repaired. CEO Wright inquired as to who cut down the hill -- KWA or the LCRC? Mr. Monson indicated it was cut down in a gradual process. Most of the grading is now down in the ditches.
- Destain Gingell Lapeer County Road Commission Acknowledged that he just received the memorandum authored by John O'Brien to Jeff Wright but hasn't had time to go over it. However, he wanted to let the Board know he does not concur with everything in the memorandum but will further review it and respond. He further indicated he doesn't want to go into litigation on all of the projects and would like to set some meetings up to resolve the remaining issues. He indicated the LCRC is still due inspection fees for services performed during the course of the project.

Board Comment:

• Mr. Mays acknowledged receiving the handouts, and began to discuss some of the issues that are involved in the litigation. CEO Wright reminded Mr. Mays that we are not allowed to discuss litigation items. He reminded the Board that it was the Lapeer County Road Commission that forced the KWA into the court system, and that each time the KWA has gone before the Court, KWA has prevailed. He does believe that this is the only way certain issues are going to be resolved. CEO Wright indicated that the court system has now assigned a special master to review the Lapeer County Road Commission's position and the KWA's position. The special master has spent the last several months reviewing all documents, reports, has conducted interviews of employees and is supposed to come out in the near future with his findings on the disputes. CEO Wright added that the first time he heard that Goodland Township needed \$21,000 was in the Lapeer County Press. He indicated he was not in a position to respond to that at this point, but he could respond to the pressure reduction valves. When the system is fully up and running, each township will be visited to discuss what their individual needs will be. He wanted to advise the Board that the KWA spent several million dollars improving drainage systems for the LCRC. Fire hydrants were also supplied for each of the townships. The KWA spent \$100,000 for hydrants and valves for the fire trucks so they could have fire suppression capabilities for the first time ever in a real sense. He indicated the Board should be proud of the fact that the KWA spent

- the extra dollars to make sure that Lapeer County and its residents had fire suppression capabilities where they have never had it before, at no expense to them.
- Joe Suma indicated he will be looking forward to receiving the special master's report and working out all of the issues.
- **Ted Henry** inquired as to how much was spent on inspection fees. CEO Wright indicated he did not have the exact figure at the moment, but indicated the KWA paid Lapeer County to hire their own inspectors to inspect properties which was about \$1.1 million. KWA also had its own inspectors on the job sites.
- Chairman Alexander indicated he received a letter putting Jamie Curtis back on the Board in the place of Richard Hammel and the Board welcomed him back.
